1	SECTION 1. REPORT ON ECONOMIC IMPACT OF TRANS-
2	SHIPMENT AND DUTY EVASION ON THE

4	(a) In General.—Not later than April 1 of each
5	year, the Commissioner responsible for U.S. Customs and
6	Border Protection shall submit to Congress, the United
7	States Trade Representative, the United States Inter-
8	national Trade Commission, and the Secretary of Com-
9	merce a report on the economic impact of transshipment
10	and duty evasion on the United States.

6	of origin; and
7	(6) the term "undervaluation" means falsifying
8	documents to undercut price and avoid duties.
