As required by the June motion\*, the True Source Honey Board of Directors met to review submitted data. It was determined that none of the data submitted warranted an amendment to the motion, and the only further action was to clarify the implementation date.

Due to delays in ocean freight bookings, it was established that any load with a House BOL date of January 1, 2026 or later would be subject to the new testing. See below or [click here](#) to view the sample document showing that date.

Where a load has an Ocean BOL date after January 1, but a House BOL date prior to January 1, the load will not be subject to the required HRMS targeted marker detection. This should represent a narrow window of time in late December where loads are in transit from inland port to ocean terminal.

The TSH Board has additionally identified and approved four qualifying methods that are compliant with the testing requirement:

- Intertek 101811
- FoodQS 380
- Eurofins PTHP1
- QSI 40802 (HRMS) + 40850 (HILIC Honey Sugar Profiling)

*\* MOTION: TSH adopts HRMS Targeted Marker detection, newly accredited testing for all origins on Bill of Ladings ship dates of January 1, 2026.
